Understanding the Challenge of Business Attraction

There are **41,683** Zip Codes in the United States – most of which would not turn down an attraction opportunity down Rational Businesses and Site Consultants want to find locations the location that will be **most profitable for the long term**

What makes the difference in Site Selection Decisions?



Site Feasibility: Why Kansas? Middle of the country

Ample agricultural land (3rd Most despite being 13th largest state)

Wind (2nd most)

Sunshine (8th most)

Oil (8th most)

Natural Gas (14th most)

Flat Terrain (7th Flattest)

Air and Water Quality (9th Best)

Site Feasibility/Timeline: Why Montgomery County?

<u>Land:</u>

Certified Sites: Independence: 305 Acres Coffeyville: 165 Acres Cherryvale: 65 Acres

Existing Buildings:

Southwire Building: 407,000 Square Feet Arco Building: 130,000 Square feet Indy Hospital: 109,200 Square Feet Vallis Building: 70,000 Square Feet

<u>Utilities:</u>

<u>Electric:</u> Relatively Cheap Industrial rates with Evergy and Coffeyville. Great Capacity. <u>Natural Gas:</u> Competitive rates with Atmos Energy and Kansas Gas Works. Great Capacity. <u>Water/Wastewater:</u> Independence, Coffeyville, and Cherryvale all have capacity in their water plants to meet the requirements of most potential projects with no significant upgrades.

Topography: All major developable sites fall in the acceptable range of slope

Environmental: A few sites have correctable environmental issues, theses can be costly in both time and money Infrastructure:

Highways: 400, 75, 160, 169 Major rail lines: Union Pacific and Watco Accessibility to: Tulsa, Jopin, Kansas City, Wichita, Catoosa

Financial Case: Why Montgomery County?

Rational businesses will choose to move to a location where they are most profitable for the **long term**.
